





# Harry was born 3 March 1835


- In Toulminville, founded by his father
- Educated at private schools, entered the University of Alabama at age 16



- Additional study at the Univ. of VA and LA
- Studied the law and began to practice in 1860 in New Orleans
- At the start of war, enlisted as private in 22<sup>nd</sup> Alabama Infantry




### Harry fought at Shiloh, Murfreesboro, Chickamauga & Atlanta...



#### ...was wounded 3 times and rose to Colonel & acting Brigadier General

# Harry wrote a classic account of the battle of Chickamauga



US cavalry sword captured at the Battle of Chickamauga, Sept. 19, 1863 by Captain Harry Toulmin, CSA


# Harry was a Presidential Elector

The Mobile ratification meeting was a grand success. The Register says it was evident that in the coming canvass the white men of Mobile, at least, will move in solid phalanx in the constitutional ranks. Mr. Daniel Wheeler was chosen President, and Mr. Harry T. Toulmin Secretary. Speeches were made by Admiral Sommes, Col. Herndon, Judge Jones, Hon. Percy Walker, Major St. Paul, and other prominent Democrate, The following resolution was unanimously adopted:


Resolved, That we, the people of Mobile, do cordially endorse and ratify the nomination, by the Democratic National Convention, of floratio Sevmeur for President and Frank P. Blair for Vice President.



## Judge Toulmin died 12 Nov 1916


#### JUDGE HARRY TOULMIN SUMMONED BY DEATH

Mobile, Ala., November 12.-Judge Harry Theophilus Toulmin, United States court, southern district of Ala-bama. died here tonight at 9 o'clock at his home in Toulminville. He was stricken with paralysis last Friday. This December he would have served thirty years on the federal bench. Recently he notified President Wilson of his intention to retire December 1, but his resignation had not been accepted. He was born in Toulminville March 4, 1835. At 16 he entered the University of Alabama and later took courses at the Universities of Virginia and Louisiana. After practicing under the code of Napolcon in New Orleans for a year he returned to Alabama. When the civil war bloke out he entered it


as a private and was discharged as a brigadier general.

When this district was supplied with the federal court, President Cleveland appointed him judge in 1887. Since that time he has served in the circuit court of appeals with federal judges everywhere in the south except Texas.

His widow, Mrs. Mary M. Toulmin: four nephews, seven nieces and other relatives survive him.
